The different types of gift you could leave

There are four main ways you can include a gift to Prospects Across Scotland in your Will and help our vital work. However you choose to help, we'd be grateful for whatever type of gift you decide to leave us.

Fixed sum of money

Also known as a pecuniary gift, this is a gift of a specific amount of money. If you do decide to leave this type of gift, it's worth reviewing from time to time as inflation can reduce its value.

Gift of a specific item

You can also choose to leave a particular item to Prospects Across Scotland, such as a piece of jewellery, an antique or even a property. A gift like this should be named in your Will.

A share of your estate

Once you've provided for your loved ones, you can leave a share of whatever remains to Prospects Across Scotland. It can be any percentage you like, it's up to you. And because this gift is a proportion of your estate, it keeps pace with inflation.

Discretionary Trust

This gift provides financial support for a loved one after your death. In the sad event of their passing, all or part of the remaining estate can be left to Prospects Across Scotland or other causes that are close to your heart.

Your questions answered.

There can be a lot to think about when it comes to making or adapting your Will. Here are answers to some of the questions you might have.

Do I have to make a Will?

Making a Will is the only way to make sure your family and friends are provided for in the way that you want. Otherwise, your exact wishes may not be carried out after you die. It's also important to make a Will to protect your loved ones from an unwelcome tax bill.

Do I need a solicitor?

No, but we'd always recommend that you use a solicitor. It's extremely important that your Will contains the correct legal wording.

Can you recommend a solicitor?

Can I change my existing Will to include a gift?

Yes, simply ask your solicitor to add a codicil to your Will. It's also a good idea to regularly review your Will to make sure it's up-to-date with your circumstances. For example, there may have been births, deaths, marriages or divorce in your family since you last looked at your Will.

How will my gift be used?

Prospects Across Scotland will use your kind gift to create opportunities for people with learning disabilities to hear a Gospel message in a relevant way and be fully included in Church communities.

What if I can only leave a small gift?

Every gift we receive, large or small, can help transform the lives of people with learning disabilities, so we're extremely grateful for whatever you can spare.

Do I need to think about inheritance tax?

There's no tax payable on a gift left to charity in your Will. What's more, it could reduce the total amount of your estate that may be liable for inheritance tax.
